- Front and side elevation
- Perspectives (1 per façade), with legible name and signature of the qualified professional (responsible for the project) and telephone for contact
- A.R.T. / R.R.T. of the project and execution with payment of the respective fee
- A.R.T. / R.R.T. of electric with payment of the respective fee
- Copy of the CAU/CREA Wallet
- Term of Responsibility duly completed and signed

For the analysis of the project, the documents must be sent by the deadline. It will not be allowed the construction of the booth that is not with the project approved by Route 183 Assessoria e Eventos LTDA which is responsible for the evaluation and release of the assembly of EXPOGEF RIO 2023.



ATTENTION:

- The assembly of the booth will be released upon approval of the project, discharge of all debts of the exhibitor and the assembler. It is of paramount importance, for inspection reasons, to keep the copy of the project and A.R.T./R.R.T. in the booth during the entire period of assembly and realization of the event.
